

# Wing Privacy Policy - Updated 11/29/2023

This policy outlines how Wing Social, “we”, “our”, or “us” collects and uses your information when using our mobile application. For the purpose of clarity, and transparency, we would like to strongly emphasize that:

**Wing does not sell your personal information to any third party.**

## Information Collected

Wing collects information about you when you use our mobile application and Services, depending on the service or feature being used. This is a necessary part of our ability to provide these services and features to you. This information may include data directly provided to us by you, data we obtain through your interaction with our application and services, and data obtained by any other source.

Wing gathers information to help you establish meaningful connections and improve your experience using our services. This includes but is not limited to:

Directly Provided Information: You choose to give us certain information when you use our services.

- Upon account creation, you provide us with your phone number, email address and basic profile details (e.g., gender, date of birth).
- When you complete your matching survey, you share your preferences for connections like sexual orientation, ethnicity, religious and political views with us.
- When you complete your profile, you share additional elements such as details on your bio and your interests, as well as content such as photos, videos, and audio clips. You may allow us to access your device's camera, photo album, or microphone if requested for certain content types.
- When you participate in surveys, focus groups, or beta testing, you give us your feedback into our product, responses to our questions, and testimonials.

Information from Third Parties: we also receive information about you from others.

- When other users interact with you or submit a report involving you, they provide information about you as they use our services.

Automatically Collected Data: when you use our services, this generates data about how you've used our services, see below for more information.

- When you use our services, this generates data such as app features used, interactions with other users, and access logs.

- We collect device information including IP addresses, device IDs, app settings, and crash reports.
- Information is collected from cookies and similar technologies (ex. Web beacons, pixels) to recognize you and your device.

## **Information Processing and Disclosure**

We may use this information for:

- Providing products, services, or information to you through our application.
- Respond to queries or questions regarding our services.
- Enforce and Terms and Conditions made between you and Wing.
- Communicate with you about any updates to products, services or agreements.
- Comply with legal obligations as required by federal and state laws.
- Compare information accuracy and verify compliance.
- Prevent and respond to any unauthorized access or usage of our services or breaches to any agreements.

We may disclose your information for any of the following reasons:

- Profile information associated with your account may be read, collected, and used by any “friends” or “matches” on your account. Some of this information may remain even after termination of your account, and so we advise caution when considering the information to select and upload to our services.
- We may disclose information if we believe any of your actions are inconsistent with any agreements between you and Wing.
- We may disclose information due to any involvement or connection with a merger, acquisition, or sale of assets between Wing and any future parent, subsidiary, or affiliated partner.
- We may disclose information as otherwise required or permitted by law, or as authorized by you.

## **Retention of Information**

Information collected by us will be kept for as long as it is useful and necessary to fulfill the purposes for which it was collected, and to provide our services to you. In addition, data will be kept as necessary to comply with all possible legal claims, business interests, and/or any applicable laws. After any such cases, information will either be deleted by us, or de-identified.

## **Privacy Policy Changes**
